DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Built in 1835 by Alexander McGregor, a Scotch stonemason who had moved to Newport, the Perry Mill is a monumental, rectangular, stone structure set with its east end to Thames Street on Newport's waterfront. Now much altered, the building is three stories tall with a flat roof, nineteen bays long and four bays wide across the streetfront. The building is characterized by its beautiful stonework; the walls are built of a native stone, random ashlar, warm sandy-brown in color, and the white granite of the quoins and of the sills and lintels of the six-over-six double hung sash windows provides simple, crisp detail.

The mill was originally four stories in height, capped by a tall basilican roof with a full-length monitor and an imposing wooden tower of Greek Revival detail. The roof and fourth floor have since been removed, and the tower has been replaced with a simple brick stair-tower on the south side. Other alterations include a brick tower and loading dock built into the rear of the north side, and a simple plate-glass storefront which has been built into the Thames Street end. The interior has also been remodeled to fit modern industrial needs and contains simple work areas and office space.

STATEMENT OF SIGNIFICANCE

The Perry Mill was one of four mills erected along Thames Street in the 1830's and 1840's in an attempt to revive Newport's failing economy by introducing textile manufacturing. The Perry Mill and the Newport Steam Factory, now the Newport Electric Company, are the only mills remaining from this short-lived venture.

Built by Alexander McGregor, the structure is of the greatest architectural importance for its magnificent stonework. The walls of Fort Adams, built in 1833, and the Newport Artillery Company's Armory on Clarke Street give further witness to McGregor's skill as a mason.

The mill is preserved as a splendid example of the artistry attained by stone craftsmen working in New England in the early nineteenth century.




GEOGRAPHICAL LOCATIONS
