DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

Silas Clapp built his house on his family's 100-acre farm in 1804, two years after his marriage. The couple populated the house with six children whose descendants retained ownership of the property until 1883. Since that date the house has been lived in by a succession of sympathetic owners, enabling it to survive intact and in good condition.

The main section of the house is a two-and-a-half-story rectangular block measuring 31 ft. by 35 ft. 6 in. To this is attached at the rear northeast corner a 12 ft. by 12 ft. ell of c.1900. The house rests on a cut fieldstone foundation, has a timber frame covered with clapboarded cedar planking on the front and shingled planking elsewhere. It is covered with a wooden shingled gable roof without a ridge pole. There is one central brick chimney, 9 feet square on the first floor and 6 feet square on the second floor.

The entrance is emphasized with a broken dentilled pediment resting on fluted pilasters with boldly projecting capitals. Above the door is a semi-circular leaded fanlight with arrow patterned radial muntins. Both door and fanlight have frames embellished with grooves horizontally extending in alternating lengths from the outer edge of the frame towards the opening. A moulded keystone crowns the fanlight. The bases of the pilasters are restorations and the door is a twentieth-century replacement. Two doors in the ell provide access to the house from the east side and rear.

The windows are all reproduced, six over six double hung, many with old glass. Splayed flat lintels cap the first story windows and all of the windows on the gabled ends of the house. Each has a projecting sill. The house is without further detail as even the main cornice has no moulding or returns.

The original five room plan has been modified with baths on both floors and the ell on the first floor. Modern bath, storage, and kitchen facilities have been confined to the rear corner rooms and thus the original sense of interior space has been largely preserved. All of the interior woodwork is original and in excellent condition. The interior doors have either four or six panels, the cased corner posts are beaded, the cornices and chair rails are simply moulded, and the floors are of wide pine boards.

The front staircase has a moulded handrail, closed stringcourse with bolection moulding, diagonally set square balusters, square newel posts capped by spheres, and acorn pendants on the angle-posts. The fireplace in the southwest parlor is decorated with a band of short fluting above a Greek key design on the cornice, a double paneled frieze, a vertical



panel to either side of the frieze to suggest pilasters, and mitered ears. In the southeast parlor the fireplace is slightly simpler with two rows of short fluting on the cornice, a plain frieze bordered with vertical panels, and mitered ears. The walls of the original kitchen are horizontally sheathed below the chair rail and plastered above while the ceiling beams are exposed.

The house faces south on approximately an acre of land. Most of the original 100-acre farm remains undeveloped woodland and pasture and under single ownership. To the east of the house is an early nineteenth-century corn crib covered with wood shingles and resting on nine granite piers. A later shed, carriage house converted into a garage, and a well, are to the east and rear of the property. Old fruit trees and lilacs and stone walls on the north and partially on the south side of the property give a sense of the building's original rural setting.

The Silas Clapp House is representative of the federal farmhouses built in rural Rhode Island. Its plan and most of its architectural detail reflect the building practices of twenty five years earlier. Only the leaded fanlight over the front doorway reveals the 1804 date of construction. The house has been well-preserved and little altered for modern living while the original farmlands remain undeveloped. As such the Silas Clapp House is an excellent example of the vernacular building once common in rural Rhode Island. It is of great importance to West Warwick as few buildings from previous centuries have survived in that town and the area is gradually becoming commercialized.


